WAIVER: In consideration of my child's participation in the activities of the Prompt Succor Athletic Program, I do hereby agree to hold free from any and all liability Prompt Succor and its coaches, officers, employees and members, and do hereby for myself, my heirs, executors and administrators waive, release and forever discharge any and all rights and claims of damages which I/my child may have to which may hereafter occur to me/my child arising out of or connected with me/my child's participation in any activities of the Prompt Succor Athletic Program.

To participate in sports, students must maintain a C average in each major and minor subject and have an A or B in conduct in Renweb. **Students who are absent from school shall NOT be allowed to participate in practice or play in a game on the day they are absent.**

The OLPS athletic policy states the following:

- a. Grades will be evaluated by the administration weekly throughout the season on RENWEB, beginning two weeks prior to the first game. If a student's grades are below the minimums listed above, he/she will be placed on probationary status. The administration will notify the Faculty Sponsor who will then relay that information to the Athletic Director, the head coach(es), and the student's parents.
 - i. The probationary period will become effective the day after eligibility is determined and last until their average is brought up to a C. During this time, a player is eligible to participate in practice sessions, but will **NOT** be eligible to participate in any games.

ii. Students failing to achieve the minimum required academic standards at the end of a two week probation will be ineligible for any participation including practice or attending games, until the student and his parents meet with the Assistant Principal to discuss whether or not the student can continue on probation or if that student needs to be dismissed from participation in events for the remainder of the athletic season(s) in progress. However, students may participate in the next athletic season, provided they meet the academic requirements prior to the team's selection. (i.e. tryouts for baseball or softball)

Example: A male student is listed on the football and basketball roster and is placed on probation after the first grade check is released. At the end of the two week probation period, if his grades do not meet the minimum standards, he and his parents will meet with the assistant principal to discuss future participation on **BOTH** the football and basketball teams. If it is decided that the student shall be dismissed from **One or Both** of the teams, that student would still be eligible to play on the soccer and/or baseball team, provided he meets the eligibility standards at the time of the tryout.

- b. A student who receives an F in conduct OR who is involved in any event at school resulting in disciplinary action by the administration will be dismissed from any team(s) in which he/she is currently participating.
- c. There will be **NO** refund of the registration fees or uniform fees for any student who is dismissed from the team due to academic or disciplinary reasons. In the case of football, the uniform deposit will be returned once the complete uniform and equipment have been returned to the school.

The OLPS Faculty sponsor when receiving news of an ineligible player will contact the Athletic Director and the head coach of the team and let them know that said player is now ineligible until the grade average is met. They will in no way or at no time discuss specific grades of OLPS student athletes with the Athletic Director or head coach. The Faculty sponsor will then reach out to the parents to alert them of their student athlete's ineligibility issue.

Parents may contact the OLPS Faculty sponsor for their child's sport and ask for a grade re-check when they believe that their student has brought up their ineligible grade to the required minimum grade average. At that point the Faculty sponsor will ask OLPS administration to perform a grade check on Renweb and will report the findings back to the parents. If the student athlete is indeed eligible, the Faculty sponsor will then report that back to the Athletic Director and head coach.
